This policy statement is designed to give a clear explanation of Clesse UK's data processing practices. Clesse UK will be the data controller of any personal data that you submit when you register as a customer or place a direct order. Clesse (UK) Limited is registered with the Information Commissioner as a data controller under registration number ZA328109.

What information do we collect from you?

As a supplier, Clesse UK needs to keep and process information about you. The information we hold and process will be used for management and administrative use only. We will keep and use it to:

- enable us to run the business and manage our relationship with you effectively, lawfully and appropriately
 - o during the sales process;
 - o whilst we are supplying or procuring goods;
 - o at the time when business stops and after your account has been closed.

This includes using information to enable us to comply with any legal requirements, pursue the legitimate interests of the Company and protect our legal position in the event of legal proceedings.

• Non-Personally identifiable information such as anonymous usage data, referring/exit pages and URLs, platform types, number of clicks etc to help us understand marketing patterns, product interest and to optimize our website for a better experience. Non-personally identifiable information may be stored indefinitely.

Storage and protection of your data.

We are committed to ensuring that your information is secure. In order to prevent unauthorized access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect. The servers and cloud storage that we use to store personally identifiable information are kept in a secure environment.

How long do we keep hold of the information?

Business to business (Including personally identifiable data) – 7 years from last sales transaction

Business to consumer (Including personally identifiable data) – 7 years from last sales transaction

Non-Personally identifiable data - Indefinitely

If in the future we intend to process your personal data for a purpose other than that which it was collected for we will provide you with information on that purpose and any other relevant information, including the opportunity to opt in.

Cookies

An HTTP cookie (also called web cookie, Internet cookie, browser cookie, or simply cookie) is a small piece of data sent from a website and stored on the user's computer by the user's web browser while the user is browsing. Cookies were designed to be a reliable mechanism for websites to remember stateful information (such as items added in the shopping cart in an online store) or to record the user's browsing activity (including clicking particular buttons, logging in, or recording which pages were visited in the past). They can also be used to remember arbitrary pieces of information that the user previously entered into form fields such as names, addresses, passwords, and credit card numbers.

Your Rights

Under the General Data Protection Regulation (GDPR) and The Data Protection Act 2018 (DPA) you have a number of rights with regard to your personal data. You have the right to request from us access to and rectification or erasure of your personal data, the right to restrict processing, object to processing as well as in certain circumstances the right to data portability.

If you have provided consent for the processing of your data you have the right (in certain circumstances) to withdraw that consent at any time which will not affect the lawfulness of the processing before your consent was withdrawn.
